Belmont Hills Elementary School Academic Goals

Goal #1:

The percentage of **Kindergarten** students demonstrating at/near or above grade level proficiency will increase from Fall 2025 to Spring 2026 by at least 80% as measured by the Amira in Spring 2026.

Students in grades **1st – 2nd** will increase their scale score by an average of 50 points from Fall 2025 to Spring 2026 as measured by the Beacon assessment.

The percentage of **3rd – 5th** grade students scoring proficient and distinguished in ELA will increase from 17% to at least 20% as measured by the 2025 – 2026 Milestone EOG ELA Assessment.

Goal #2:

At least 80% of **Kindergarten** students will demonstrate proficiency by scoring 75% or higher in mathematics as measured by the CCSD Evidence of Student Learning assessment by the end of each unit.

Students in **1st – 2nd** grade will increase their scale score by an average of 80 points from Fall 2025 to Spring 2026 as measured by the Beacon assessment.

The percentage of **3rd – 5th** grade students scoring proficient and distinguished in Math will increase from 31% to at least 34% as measured by the 2025-2026 Milestone EOG Math Assessment.

School Plan for Shared Student Achievement



What is it?

This is a plan that describes how Belmont Hills Elementary will provide opportunities to improve family engagement to support student learning. Belmont Hills Elementary values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Belmont Hills Elementary will support family engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

Jointly Developed

Belmont Hills Elementary invites all parents to complete the Fall school improvement input survey/evaluation to provide suggestions on the school's Title I program. All parents are also invited to attend the Spring school improvement input meeting to revise this parental involvement policy, our school-parent compact, building staff capacity professional learning topics, and the parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year. The plan is posted on our school Web site for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Belmont Hills Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

Belmont Hills Elementary is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

- By SY26, increase growth by 2 percentage points, for students scoring at the proficient and distinguished levels, as evidenced by state assessments.
- By SY28, increase graduation rate from 87% to 88% as measured by GaDOE adjusted cohort graduation rate.

Belmont Hills Elementary will take the following measures to promote and support parents as an important foundation of the school in order to strengthen student academic performance and reach our school goals. We will:



- ✓ Ensure that all information related to school and parent programs, meetings, and other activities is published in both English and Spanish, posted on the school website, and included in the CTLS parent newsletter.
- ✓ Provide one training each semester for staff during their planning periods on strategies to improve communication with parents and ideas to increase family engagement.
