

### Advanced Content in Middle School

#### Advanced Content Placement Procedures

Students are placed in Advanced Content classes based on the following guidelines:

#### Method 1: Gifted Students

Students who are identified as "Gifted" receive immediate spots in AC classes based on areas in which they excel. Georgia requires that gifted-identified students are served in AT LEAST ONE advanced content class. In Georgia, there are two methods used to identify students as "Gifted." Option A (both requirements must be met):

- 98th percentile composite score on CogAt
- 90<sup>th</sup> percentile in Total Reading, Total Math, OR composite score on IOWA

Option B (requires meeting THREE of the following four criteria):

- 98th percentile on any component score of the CogAt
- 90<sup>th</sup> percentile on Total Reading, Total Math, or Complete Battery on IOWA
- 90<sup>th</sup> percentile on a nationally normed creativity test (Georgia uses the GES-3)
- 90<sup>th</sup> percentile on a motivation inventory assessment (GES-3 or G.P.A.)


## Method 2: High Achieving Students

After gifted students are placed in AC classes, high achieving students are considered for any available openings. High achieving students are not identified as gifted, but they show an ability to handle more rigorous curriculum.

High achieving students are identified based on their IOWA and CogAt scores first. Previous grades and end-of-year tests may be used as a second indicator if deemed appropriate by teachers and administration. High achieving students are treated on a priority system, so the highest scoring students are admitted to open AC classes first. Students are not served on a "first come, first served" basis, and previous AC placement at Barber or another school does NOT guarantee AC placement in any subsequent year at Barber.

What are the recommended guidelines for 8th grade placement?

Local schools may choose one of the following options for determining qualified students at their school.

Students with a Total Reading or Total Math score on the IOWA less than 80% or an EOG designation of Basic or Developing are not eligible to participate.

<u>Algebra/HS Physical Science Placement –</u> 8<sup>th</sup> grade students must have a minimum of 6 points to qualify for AC coursework in this subject.
