AUTHORIZATION TO GIVE MEDICATION

If medication can be given at home, before or after school hours, please do so. If medication must be given during school hours, this Form must be completed and filed with the School Clinic. Pharmacists may provide two labeled bottles for this purpose. Medications sent in an unlabeled container will not be given. If your child takes daily medication, please send an extra bottle to be used for field trips and After School Program. Written permission of the parent/guardian is required for the administration of all medications. The parent/guardian must inform the school of any medication changes. New medication or new doses will not be given unless a new form is completed. Medications must be brought to the office/clinic by the parent/guardian. Unused medication will be disposed of unless picked up within one week after medication is discontinued. If medication is given throughout the school year, medication will be disposed of according to the medication Rule Section IX. Completion of this form for prescription medication authorizes Cobb County School District Health Services to discuss the medication order/request with the prescribing healthcare provider if indicated and/or needed.
