CITY VIEW Academic Goals

Goal 1: By Spring 2026, the percentage of 1st and 2nd grade students scoring Prepared across ELA domains on the Beacon ELA Spring Assessment will increase from 25% to 29%, as measured by the 2026 Beacon Spring Administration. By May 2026, the percentage of students in grades 3–5 scoring at or above the Developing Learner (Level 2) on the Georgia Milestones ELA Assessment will increase from an average of 49.24% to 53%, as measured by the Spring 2026 Georgia Milestones End-of-Grade Assessment.

Goal 2: By Spring 2026, the percentage of 1st and 2nd grade students scoring Prepared across all math domains on the Beacon Math Spring Administration will increase from an average of 23% to 28%, as measured by the 2026 Beacon Spring Assessment. By May 2026, the percentage of students in grades 3 - 5 scoring Proficient or Distinguished on the Georgia Milestones Math Assessment will increase from an average of 17.6% to 25%, as measured by the 2025 Georgia Milestones End-of-Grade Assessment.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how CITY VIEW Elementary School will provide opportunities to improve family engagement to support student learning. Parents can also give feedback during any parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. CITY VIEW Elementary School will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

CITY VIEW Elementary School is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.
