Compton Elementary School Academic Goals

Goal #1:

<u>K-2 Literacy Goal</u>-The percentage of students s coring "At or Above" Grade Level for grades K-2 will increase from 47% (146 students out of 312 students) to 53% (165 students out of 312 students) as measured by the 2024-2025 Spring Amira screening results.

3-5 Literacy Goal-The percentage of 3rd through 5th grade students scoring in the "Meets" Range will increase from 26% (71 students out of 268 students) to 33% (89 students out of 268 students) as measured by the 2024-2025 EOG ELA Assessment.

Goal #2:

<u>K-2 Math Goal</u>-The percentage of 1st and 2nd grade students scoring "Prepared" (per their quantile) will increase from 23% (51 students out of 218 students) to 29% (63 students out of 218 students) as measured by the 2024-2025 Spring Beacon Assessment.

3-5 Math Goal-The percentage of 3rd through 5th grade students scoring in the "Meets" Range will increase from 26% (70 students out of 271 students) to 32% (86 students out of 271 students) as measured by the 2024-2025 EOG Math Assessment.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Compton Elementary will provide opportunities to improve family engagement to support student learning. Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Compton Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

Compton Elementary is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement.
