#### Riverside Elementary Academic Goals

#### **Goal #1** -Primary Reading Goal:

The percentage of students in kindergarten through second grades with an Amira ARM score at the 50<sup>th</sup> percentile or higher will increase from 30% (56 students) to 50% (93 students) by the end of the 2024-2025 school year.

#### Goal #2 - Intermediate Reading Goal:

The percentage of third-fifth grade students scoring Level 3 or higher will increase from 10% (25 students) to 25% (64 students) on the Milestones ELA Assessment by the end of the 2024-2025 school year.

#### **Goal #3 - Primary Math Goal:**

The percentage of students in first and second grades scoring Prepared on the Math Beacon Assessment will increase from 27% (54 students) to 50% (84 students) by the end of the 2024-2025 school year.

#### Goal #4 - Intermediate Math Goal:

The percentage of third-fifth grade students scoring Level 3 or higher will increase from 16% (41students) to 30% (77 students) on the Milestones Math Assessment by the end of the 2024-2025 school year.

**Goal #5** - The number of students who receive a referral that results in an out-of-school suspension will decrease from 8 % (39 students) to 5% (26 students) by the end of the 2024-2025 school year.

## **School Plan for Shared Student Achievement**

### What is it?

This is a plan that describes how Riverside Elementary will provide opportunities to improve family engagement to support student learning. Riverside values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. ## **Jointly Developed**

We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

### Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Riverside Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

### Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

### What is Title I?

Riverside Elementary is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

- By SY26, increase growth by 2 percentage points, for students scoring at the proficient and distinguished levels, as evidenced by state assessments.
- By SY28, increase graduation rate from 87% to 88% as measured by GaDOE adjusted cohort graduation rate.

Riverside Elementary will take the following measures to promote and support parents as an important foundation of the school in order to strengthen student academic performance and reach our school goals. We will:
