### **Acworth Elementary Academic Goals**

- **Goal 1:** The percentage of students in 3<sup>rd</sup>-5<sup>th</sup> grade scoring Proficient or Advanced on the ELA Milestone will increase from 42% to 46% by the end of the 2025-2026 school year.
- **Goal 2:** The percentage of students in 3<sup>rd</sup>-5<sup>th</sup> grade scoring Proficient or Advanced on the Math Milestone will increase from 44% to 48% by the end of the 2025-2026 school year.

# School Plan for Shared Student Achievement

## **What is it?**

This is a plan that describes how Acworth Elementary will provide opportunities to improve family engagement to support student learning. Acworth Elementary values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Acworth Elementary will support family engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.



## **Jointly Developed**

Acworth Elementary invites all parents to complete the Fall school improvement input survey/evaluation to provide suggestions on the school's Title I program. All parents are also invited to attend the Spring school improvement input meeting to revise this parental involvement policy, our school-parent compact, building staff capacity professional learning topics, and the parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year. The plan is posted on our school Web site for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

## **Who is it for?**

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Acworth Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

## **Where is it available?**

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

## **What is Title I?**

Acworth Elementary is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

## **2025-2026 Cobb County Schools District Goals**

- By SY26, increase growth by 2 percentage points, for students scoring at the proficient and distinguished levels, as evidenced by state assessments.
- By SY28, increase graduation rate from 87% to 88% as measured by GaDOE adjusted cohort graduation rate.

Rising 2<sup>nd</sup> grade families are introduced to expectations and learning opportunities offered in elementary school.

### **Rising 6<sup>th</sup> Grade Parent Meeting- April 17<sup>th</sup>, 2026**

Rising 6<sup>th</sup> Grade families are introduced to expectations and learning opportunities offered in middle school.

### **Other Parent Activities Provided by Acworth Elementary**

#### **Parent VUE/ CTLS Meeting – September 11, 2025**

Parents will receive training on how to utilize Parent Vue and CTLS effectively to monitor their child's academic progress and communicate with teachers.

#### **Math Fact Fluency Support – March 19, 2025**

Parents will learn strategies for supporting their child's math fact fluency as well as receive information on utilizing Reflex Math support site at home.

## **Family-School Compacts**

As part of this plan, Acworth Elementary and our families will develop a family-school compact, which is an agreement that parents, teachers, and students will develop that explains how parents and teachers will work together to make sure all our students reach grade-level standards. The compacts will be reviewed and updated annually based on feedback from parents, students, and teachers during the School Improvement forum.
