Garrett Middle School Academic Goals

Goal 1: ELA From Spring 2026 to Spring 2027, the average ELA BEACON scale score for each grade level will increase by at least 15 points:

- 6th Grade - 468 to 483
- 7th Grade - 502 to 517
- 8th Grade - 524 to 539

Goal 2: MATH By May 2027, the number of students scoring at a Level 2 (Developing Learner) and above on the Math EOG will increase from 74.6% to 80%.

Goal 3: SCIENCE By May 2027, the number of students scoring at Level 2 (Developing Learner) and above on the Science EOG will increase from 63.8% to 70%.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Garrett Middle School will provide opportunities to improve family engagement to support student learning. Garrett Middle School values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. Jointly Developed

Garrett Middle School invites all parents to complete the Fall school improvement input survey/evaluation to provide suggestions on the school's Title I program. All parents are also invited to attend the Spring school improvement input meeting to revise this parental involvement policy, our school-parent compact, building staff capacity professional learning topics, and the parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year. The plan is posted on our school Web site for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Garrett Middle School will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

Garrett Middle School is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

- By SY29, increase growth by 2 percentage points, for students scoring at the proficient and distinguished levels, as evidenced by state assessments.
- By SY29, increase graduation rate from 89% to 91% as measured by GaDOE adjusted cohort graduation rate.

Rising 9th Grade families are introduced to expectations and learning opportunities offered in high school.

Curriculum in Action Night – September 17, 2026, 6:00 PM to 7:30 PM

Teachers will share curriculum concepts with parents. The parents will have an opportunity to see what their child is learning in school.

Family Data Night – January 26, 2027, 6:00 PM to 7:00 PM

Parents get a better understanding of their children's academic performance in school. Families get their child's scores from standard test and are informed on what their child needs to do to excel.
