Academic Goals

GOAL 1:

By the end of the 2025-2026 school year, the percentage of grades 3-5 students performing proficient or above as measured by the EOG ELA milestones assessment will increase from 37.2% (70 out of 188 students) in the Spring of 2025 to 45% in the Spring of 2026.

By the end of the 2025-2026 school year, the percentage of K-2 students reading on grade level will increase by 10% from baseline assessment, based on Amira Lexile measures.

GOAL 2:

By the end of the 2025-2026 school year, the percentage of 3-5 students performing proficient or above in mathematics as measured by the EOG Math Milestones assessment will increase from 61% (113 out of 186 students) in the Spring of 2024 to 66% in the Spring of 2026.

By the end of the 2025-2026 school year, the percentage of 1-5 students scoring on grade level will increase by 10% from baseline assessment, based on Beacon Assessment Math measures.

By the end of the 2025-2026 school year, the percentage of kindergarten students scoring on grade level will increase by 10% on the CTL5 End of Unit Math Assessment.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Austell Elementary will provide opportunities to improve family engagement to support student learning. Austell Elementary values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. Jointly Developed

Austell Elementary invites all parents to complete the Fall school improvement input survey/evaluation to provide suggestions on the school's Title I program. All parents are also invited to attend the Spring school improvement input meeting to revise this parental involvement policy, our school-parent compact, building staff capacity professional learning topics, and the parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year. The plan is posted on our school Web site for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Austell Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

Austell Elementary is identified as a school having a Schoolwide Title I program as part of Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

- By SY26, increase growth by 2 percentage points, for students scoring at the proficient and distinguished levels, as evidenced by state assessments.
