- i. The child lives in the following GA counties: Cobb, DeKalb, Fulton, Gwinnett, Clayton
- ii. The child must be under 17.5 years of age or younger on the date of referral.
- iii. The child must be eligible for legal relief such as SIJS, Asylum, U Visa, T Visa.
- iv. The child must have entered the country as an unaccompanied alien child, (this means that the child must have entered the U.S. without a parent or legal guardian)
- v. At present, the child may not reside with one or both parents to receive services from KIND's Atlanta office, unless the child's primary relief is not SIJS.
