<u>Goal #1:</u> By the end of the 2024-2025 school year, the number of students scoring level I on the ELA EOGs will decrease by 15%.

**Goal #2:** By the end of the 2024-2025 school year, the number of students scoring level I on the Math EOGs will decrease by 15%.

## **School Plan for Shared Student Achievement**

### What is it?

This is a plan that describes how Pearson will provide opportunities to improve family engagement to support student learning. ### Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Pearson will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

### Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

#### What is Title I?

Pearson is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement.
