Russell Elementary Academic Goals

<u>Goal #1</u>: The percentage of kindergarten, 1^{st} grade, and 2^{nd} grade students coring at/above grade level will increase from 32% (92 students) to 40% (115 students) as measured by the 2024-25 AMIRA. The percentage of 3^{rd} , 4^{th} , and 5^{th} grade students scoring levels 3 and 4 will increase from 29% (76 students) to 35 % (93 students) as measured by the 2024-25 ELA Georgia Milestone.

<u>Goal #2:</u> The percentage of 1st and 2nd grade students scoring proficient and advanced will increase from 27% (54 students) to 33% (67 students) as measured by the 2024-25 Math Beacon quantile. The percentage of 3rd, 4th, and 5th grade students scoring levels 3 and 4 will increase from 32% (64 students) to 38% (72 students) as measured by the 2024-25 Math Georgia Milestone.

<u>Goal #3</u>: The percentage of 5th grade students scoring levels 3 and 4 will increase from 42% (42 students) to 48% (45 students) as measured by the 2024-25 Science Georgia Milestones.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Russell Elementary will provide opportunities to improve family engagement to support student learning. Russell Elementary values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. Jointly Developed

Russell Elementary invites all parents to complete the Fall school improvement input survey/evaluation to provide suggestions on the school's Title I program. All parents are also invited to attend the Spring school improvement input meeting to revise this parental involvement policy, our school-parent compact, building staff capacity professional learning topics, and the parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year. The plan is posted on our school Web site for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Russell Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

Russell Elementary is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

Parents and educators review and discuss Russell Elementary's Title I program, future parent activities, school-family compact and policy, family engagement budget and staff trainings.

Incoming kindergarten Parent Meeting- June 24-27, 2024

Rising kindergarten families are introduced to expectations and learning opportunities offered in elementary school.

Other Parent Activities Provided by the School with Descriptions are listed below.

STEM Night is one night in which students and their families are exposed to STEM activities, STEM companies, and STEM speakers.

Academic Engagement Nights are quarterly events in which each grade level presents families with students results (Reading Beacon, Math Beacon, and Science data).

Wellness & Fitness Night is one night in which students and families are provided health resources from local agencies, educational sessions, and healthy physical activities.

PTA October Tailgate/Spring Fling are events provided by PTA to bring families together and support community collaboration.

Grade Level Parent Nights are grade-level meetings with families every 4 ½ weeks to discuss priority standards and real-world strategies to support students at home.

Russell Elementary will take the following measures to promote and support parents as an important foundation of the school in order to strengthen student academic performance and reach our school goals. We will:
