

## **SAT/ACT Test & Application Fee Waivers**

Fee waivers are available to low-income 11th- and 12th-grade students in the U.S.

1. Review the “Eligibility” requirements below to determine if you qualify for a fee waiver.
2. You can provide a copy of the email your parent received confirming your eligibility for free/reduced lunch or complete this [FORM](#) and return it to the counseling office.
  - If you need a copy of the form, please stop by the School Counseling Office. We are located at the end of the 100 Hall/Café Hallway.
3. Once we receive either of those documents, your School Counselor will email you the Fee Waiver using Naviance. You will need to check your Naviance messages, or your personal email associated with your Naviance account to receive the waiver.

<p><b>Eligibility:</b></p> <p>You're eligible for fee waivers if you say "yes" to any of the following:</p> <ul style="list-style-type: none"> <li>➤ You're enrolled in or eligible to participate in the National School Lunch Program (NSLP).</li> <li>➤ Your annual family income falls within the Income Eligibility Guidelines set by the USDA Food and Nutrition Service. (See NOTE)</li> <li>➤ You're enrolled in a federal, state, or local program that aids students from low-income families (e.g., Federal TRIO programs such as Upward Bound).</li> <li>➤ Your family receives public assistance.</li> <li>➤ You live in federally subsidized public housing or a foster home or are homeless.</li> <li>➤ You are a ward of the state or an orphan.</li> </ul>	<p><b>Eligibility:</b></p> <p>Meet one or more of the indicators of economic need listed below:</p> <ul style="list-style-type: none"> <li>➤ Enrolled in a federal free or reduced-price lunch program at school, based on US Department of Agriculture (USDA) income levels. (See NOTE)</li> <li>➤ Enrolled in a program for the economically disadvantaged (for example, a federally funded program such as GEAR UP or Upward Bound). Note: If the student participates in a program, but is not economically disadvantaged, they are not eligible for a fee waiver.</li> <li>➤ Resides in a foster home, is a ward of the state, or is homeless.</li> <li>➤ Family receives low-income public assistance or lives in federally subsidized public housing.</li> <li>➤ Family's total annual income is at or below USDA levels for free or reduced-price lunches on the USDA Food and Nutrition Service website.</li> </ul>
