## Clarkdale Elementary Academic Goals

### Clarkdale Elementary Goal(s) for Student Achievement

#### Goal #1:

Increase the percentage of students performing at the proficient and advance levels on the Reading Inventory (RI) from 43% (519 of 510 students) at the end of 2023 school year to 50% of assessed students by the end of 2024 school year.

#### Goal #2:

Increase the percentage of students performing at the proficient and advanced levels on the Math Inventory (MI) assessment from 66 % (436 of 664 students) at the end of 2023 school year to 71% of assessed students by the end of 2024 school year.

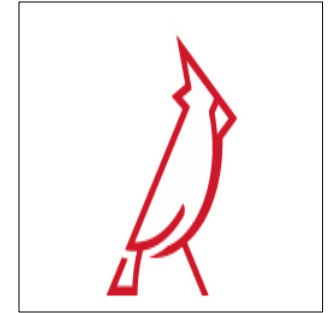
#### Goal #3

Increase the percentage of 3-5 students performing at the Monitor and Accelerate Learning levels in writing, as measured by the EOG, from 44% (155 of 352 students) at the end of 2023 school year to 49% of assessed students by the end of 2024 school year.

# School Plan for Shared Student Achievement

## What is it?

This is a plan that describes how Clarkdale Elementary will provide opportunities to improve family engagement to support student learning. Clarkdale Elementary values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Clarkdale Elementary will support family engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.



## Jointly Developed

Clarkdale Elementary invites all parents to complete the Fall school improvement input survey/evaluation to provide suggestions on the school's Title I program. All parents are also invited to attend the Spring school improvement input meeting to revise this parental involvement policy, our school-parent compact, building staff capacity professional learning topics, and the parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year. The plan is posted on our school Web site for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

## Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Clarkdale Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

## Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

## What is Title I?

Clarkdale Elementary is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

Additionally, you'll receive a description about our school's curriculum and the assessments used to monitor student progress.

**Parent-Teacher Conferences – October 17-20, 2023 (all day)**

Receive updates on your child's progress in class and on assessments during Conference Week. Parents may always request conferences with their child's teacher, as needed.

**Fall School Improvement Input Survey October 10, 2023 (Open Door)**

Clarkdale Elementary will send home the Title I Survey / Evaluation through CTLS Parent. Parents are asked to provide valuable feedback regarding the school, current and future family and community engagement activities and programs.

**Spring School Improvement Input Forum- April 17, 2024 7:15am**

Parents and educators review and discuss Clarkdale's Title I program, future parent activities, school-family compact and policy, family engagement budget and staff trainings.

**Academic Parent Teacher Team (APTT) Parent Meetings-September 12, 2023, Conference Week October 17-20, 2023, January 16, 2024, April 16, 2024, 6.00pm**

Provide an engagement model that strengthens teacher-family relationships by focusing on student academic growth and achievement. The APTT Model elevates the efforts of traditional parent-teacher conferences by inviting all families of the same classroom teacher to meet rather than individually to focus on your child's needs.

**Rising 6<sup>th</sup> Graders Parent Meeting- March 20, 2024, (Cooper Middle School)**

Opportunities offered in Middle School. Counselors assist both parents/families and students in preparation for transitioning to middle school, visits, information meetings, and written information.

**Rising Kindergarten Opportunities- June 19, 20, 21, 2024, 8:30am-12:00pm**

Clarkdale Elementary School will provide opportunities for Pre-Kindergarten students to have an early print rich environment and math exposure through the ability of activities and resources from our Parent Resource Room. Each semester, our Parent Liaison will invite parents/families of children in the 4-year- old classes at nearby local preschools to an Open House for our Parent Resource Room and will introduce the families to activities and ideas for further developing readiness for kindergarten.

**ESOL Parent Information Meeting- Friday, October 14, 2024, 7:30 am Learning Commons**

Parent activities should be developed based on feedback from the previous year's parent survey. Parents will receive information and an overview of the ESOL program, eligibility requirements and available resources. Facilitators will also share the importance of family engagement and the important roles that parents play in their student's success.

## Family-School Compacts

As part of this plan, Clarkdale Elementary School and our families will develop a family-school compact, which is an agreement that parents, teachers, and students will develop that explains how parents and teachers will work together to make sure all our students reach grade-level standards. The compacts will be reviewed and updated annually based on feedback from parents, students, and teachers during the School Improvement forum. The family-school compacts are distributed during Parent-Teacher Conference week October 19-22, 2023, Copies are also available throughout the year with each child's teacher.
