Acworth Elementary Academic Goals

Goal #1: Increase the number of students in grades 2-5 reading at or above grade-level proficiency by 30% (150 students) measured by the August 2023 to May 2024 administration of the Reading Inventory.

Goal #2: Increase the number of students in grades 3-5 that meet and exceed quarterly genre benchmark expectations by 25% by the end of Q3 as measured by the quarterly pre and post Write Score assessments during the 2023-2024 school year.

Goal #3: Increase the number of students in grades 2-5 scoring on or above grade-level proficiency by 30% (150 students) as measured by the August 2023 to May 2024 administration of Math Inventory.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Acworth Elementary will provide opportunities to improve family engagement to support student learning. Acworth Elementary values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. Jointly Developed

Acworth Elementary invites all parents to complete the Fall school improvement input survey/evaluation to provide suggestions on the school's Title I program. All parents are also invited to attend the Spring school improvement input meeting to revise this parental involvement policy, our school-parent compact, building staff capacity professional learning topics, and the parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year. The plan is posted on our school Web site for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Acworth Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

Acworth Elementary is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

- Increase student performance in all core content areas by 2% annually as measured by achievement data.
- CCSD will increase the participation rate of families and communities engaging in services/programs by 10% as measured by CTLS Parent data, survey results & web view module.
