**Performance Target: 40% of American Literature students will increase their Lexile scores by 100 points by the end of the semester which will decrease the basic level pf the American Literature EOC for 2024-25.**

- All American Literature teachers will identify current RI/Beacon score for students in their class during pre-planning.
- American Literature CCC will identify reading strategy to be used for each week based on curriculum.
- All American Literature teachers will measure each student’s Lexile monthly
- Students whose Lexile scores have not improved will be offered acceleration opportunities both in class as well as out.
