Pearson Middle School Academic Goals

Goal 1: By the end of the 2025-2026 school year, the **percentage** of students scoring in the near target or Prepared categories will **increase** from:

6th Grade: 54% on the Fall administration to 64% on the Spring administration.

7th Grade: 45% on the Fall administration to 55% on the Spring administration.

8th Grade: 56% on the Fall administration to 66% on Spring administration, as measured by the DRC Georgia ELA BEACON Assessment.

Goal 2: By the end of the 2025-2026 school year:

6th Grade: At least 70% of the students will score at Level II or Higher.

7th Grade: At least 65% of the students will score at Level II or Higher

8th Grade: At least 65% of the students will score at Level II or Higher on the Georgia Milestones Math Assessment, as measured by state testing results in Spring 2025.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Pearson will provide opportunities to improve family engagement to support student learning. Pearson values the contributions and involvement of families to establish an equal partnership for the common goal of improving student achievement. Jointly Developed

Pearson invites all parents to complete the Fall school improvement input survey/evaluation to provide suggestions on the school's Title I program. All parents are also invited to attend the Spring school improvement input meeting to revise this parental involvement policy, our school-parent compact, building staff capacity professional learning topics, and the parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year. The plan is posted on our school Web site for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey that is posted online to ask parents for their suggestions on the plan and the use of the 1% reservation of funds for parental involvement. Parents can also give feedback during any parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Pearson will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

Pearson is identified as a school having a Schoolwide Title I program as part of Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written parental involvement policy.

- By SY26, increase growth by 2 percentage points, for students scoring at the proficient and distinguished levels, as evidenced by state assessments.
- By SY28, increase graduation rate from 87% to 88% as measured by GaDOE adjusted cohort graduation rate.

Pearson will take the following measures to promote and support parents as an important foundation of the school in order to strengthen student academic performance and reach our school goals. We will:



- ✓ Ensure that all information related to school and parent programs, meetings, and other activities is published in both English and Spanish, posted on the school website, and included in the weekly (Date) message for all parents.
