Varner Elementary Academic Goals

Goal #1:

The percentage of students scoring at or above grade level for grades K - 2 will increase from 25.2% (81 students) to 30.2% (97 students) as measured by the 2024 - 2025 spring Amira screening results.

The percentage of students in grades 3-5 scoring proficient and distinguished will increase from 37% (146 students) to 42% (166 students) as measured by the 2024 - 2025 EOG ELA Assessment.

Goal #2:

The percentage of K - 2 students scoring a rating of Prepared (Quantile) score will increase from 36% (117 students) to 41% (133 students) as measured by the 2024-2025 spring Beacon universal screener results.

The percentage of students in grades 3 - 5 scoring proficient and distinguished will increase from 37% (146 students) to 42% (166 students) as measured by the 2024-205 EOG Math Assessment.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Varner Elementary will provide opportunities to improve family engagement to support student learning. Who is it for?

All students participating in the Title I, Part A program, and their parents and families, are encouraged and invited to fully participate in the opportunities described in this policy. Varner Elementary will provide full opportunity for the participation of Neglected and Delinquent proxy parents, parents and families with limited English, parents with disabilities, and parents of migratory children.

Where is it available?

Every family will receive the plan during Parent-Teacher Conference week. It is also available on the school website and a copy is in the front office binder. Parents can also retrieve a copy of the plan in the Parent Resource Center. We will gladly mail the plan to you upon request.

What is Title I?

Varner Elementary is identified as a school having a Schoolwide Title I program as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to challenging state academic standards which reinforce and enhance efforts to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement.
